NOTIFICATION

This is for information of all concerned that a Departmental Academic Integrity Panel (DAIP) be formed within 01/02/2019 as per the UGC's Notification No. F.1-I-18/2010 (CPP-II) dated 23/07/2018. The structure of the DAIP is as follows:-

- a. Chairman : Head of the Department
- b. Member : Senior Academician from outside the department to be nominated by the Hon'ble Vice-Chancellor
- c. Member : A person well versed with anti plagiarism tools, to be nominated by the Hon'ble Vice-Chancellor.

The tenure of the members in respect of points 'b' and 'c' shall be two years. The quorum for the meetings shall be 2 out of 3 members (including Chairman).

The terms of reference of the Committee is as follows:-

- ii) The DAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff.
- iii) The DAIP shall have the power to access the level of plagiarism and recommend penalty (ies) accordingly.
- iv) The DAIP after investigation shall submit its report with the recommendation on penalties to be imposed to the IAIP within a period of 45 days from the date of receipt of complaint/initiation of the proceedings.

Therefore, all HoDs are requested to submit two panels consisting of at least two names for each category of member on or before 30/01/2019 at academic@gauhati.ac.in (a sample format for submission of panel is attached herewith for reference)
