It is notified for information to all the students admitted to the 1st Semester of MA/MSc/M.Com programme in Gauhati University for the session 2023-24 that as per the Govt. OM vide ECF No.255584 dated 16/08/2023 and office order issued vide No. PC/HE/SOPD/13/2023/15 dated Kahilipara the 18th August/2023 from the Director of Higher Education, Govt of Assam, the admission fees of students of the said programmes will be waived under the Pragyani Bharati Scheme of the Govt. of Assam. The Eligibility criteria for availing the benefit of the scheme is as mentioned below:


1. The students whose parental annual income is less than Rs.2.00 lakh from all sources will be eligible to avail this scheme.
2. If either of the parents (Father/Mother) of the student is working in State Govt/Central Govt/Semi Govt or Central Govt undertaking, such student will not be eligible under this scheme.
3. The students admitted to any Self- Financing Course are not eligible under this scheme.
4. The scheme is for regular students only.

Therefore, the admission fees already deposited by the eligible students under this scheme will be refunded. The concerned students of 1st semester of MA/MSc/M.Com are directed to submit the prescribed format of application to the Head of their Department along with the following documents for the refund of admission fees **on or before 06/10/2023:**

1. The Students seeking admission under this scheme will have to plant a sapling at the university(with prior permission from the Estate Office, GU) or at his/her home and shall submit the photograph of the same to the Head of the Department along with the Form. The students have to nurse the sapling and while seeking admission into 3rd Semester shall submit the photograph of the same tree which is planted during the 1st Semester.
2. The latest Annual Income Certificate from the Circle Officer/ Head of the institution studied last. The student or his /her parents may submit a Notary/Affidavit also in respect of annual income.
3. The Admission slip of MA/MSc/M.com programme
4. The copy of online admission fee deposit receipt
5. Photocopy of first page of student's Bank Pass Book showing the Account No. IFSC Code No. etc.

The students are directed to show their original marks sheet of graduation at the time of submission of the application. The Format of Application may be downloaded from the website of Gauhati University.
