Objective:

The objective of setting up the workstation is to permit qualified researchers optimum use of anonymized micro-data from census for in-depth research by allowing access for generating cross tabulations not published by the Census. The facility is open to all bonafide users who are citizens of India (including those who are not enrolled or part of Gauhati University).

SOP for access to facility at Census Data Research Workstation:

- 1. For access to the workstation, the researcher would have to fill in the prescribed form and submit the research proposal to Hony. Director, PRC, GU through his/her controlling officer/Head of Department/ Ph.D supervisor (with seal). The empowered steering committee will examine the proposal and accord permission for obtaining data for the research, if found suitable.
- 2. The facilities available at the workstation will only be open to researchers whose proposal has been accepted and approved by the committee.
- 3. The researcher will be permitted to use only the software made available at the workstation for tabulation (i.e. CS pro).
- 4. The researchers may also use printer installed in the workstation to print the approved outputs. She/he will however not be allowed to take out the soft copy of the micro-data in any format.
- 5. The researcher shall not insert any external storage device (pen drive etc.) in any terminal/computer of the workstation. He/she shall not be allowed to use internet facility in the workstation. Any violation will be strictly dealt with.
- 6. The researcher is expected to be familiar with CS pro software and to carry out the analysis on his/her own, using CS pro. Tutorials for the same are available on online platforms.
- 7. The researcher can carry out the analysis only in the user terminals installed in the census workstation.
- 8. No digital device of any type (including mobiles, tablets and laptops) can be carried inside the Census Data Research Workstation.
- 9. By filling out the form, the researcher agrees to fulfill and abide by all the terms and conditions for using census workstation as prescribed by PRC GU from time to time.
- 10. Users have to take utmost care in using the facility and will be held responsible for damage to the printers, computers or any other in the workstation.
- 11. The facility will be available only during the University working hours.
