Important Instructions for Applicants of the Five-Year Integrated Master Programme (FYIMP) for the Session 2025–26

All candidates who have applied or are in the process of applying for the FYIMP (Session 2025–26) at Gauhati University are hereby informed to adhere to the following requirements regarding reservation categories:

1. Reservation under OBC/MOBC Category:

Applicants seeking reservation under the OBC/MOBC category must upload a valid Non-Creamy Layer (NCL) certificate. This reservation benefit is applicable only to Non-Creamy Layer candidates belonging to the OBC/MOBC community. This has already been clearly stated in the Gauhati University Information Brochure for the Academic Session: 2025-26.

2. Reservation under Other Category/Quota:

Candidates applying under any of the following categories must submit the duly filled-in prescribed form in hard copy, along with a printed copy of their application form and other required self-attested supporting documents, to the office of the Director of Students' Welfare, Gauhati University, Guwahati – 781014, Assam. Submission of form must be made in person or by post on or before May 31, 2025:

- Person with Benchmark Disability (PwBD)
- Son/Daughter of Ex-Defence Personnel
- o Extra-Curricular Activities/ Sports
- National Cadet Corps (NCC)/ National Service Scheme (NSS)
- Fringe Village (Applicable only for residents of the village located at the fringe area of Gauhati University viz. Garigaon/Sadilapur/Katia Dalang/Sundarbari)
- o Son/Daughter of Present or Retired Employee of Gauhati University

Note for Applicants:

- Candidates who have already submitted their applications may upload the required certificates during the Correction Window for Students, scheduled from May 23 to May 25, 2025.
