AGREEMENT

This agreement has been made between the FRESH AIR WASTE MANAGEMENT SERVICES PVT. LTD., FATASHIL, G.S. COLONY, GUWAHATI 781009 in the district of Kamrup, Assam herein after called the FRESH AIR.

AND

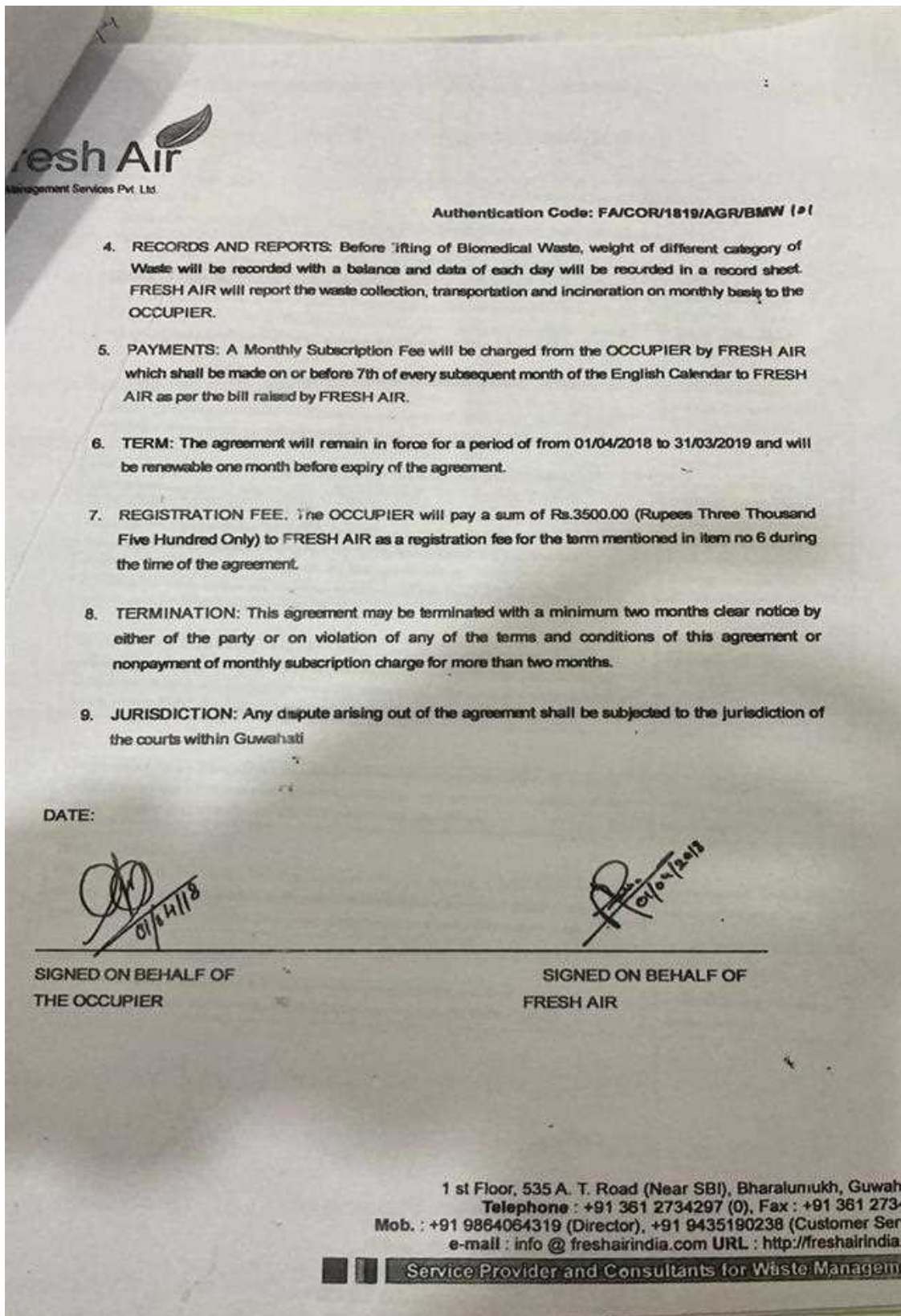
The University of Gauhati, Guwahati, Assam, Pin-781014, an educational Institution having its registered office at Jalukbari, in the district of Kamrup, Assam, INDIA hereafter called OCCUPIER.

The OCCUPIER is having certain departments under its campus which may produce hazardous materials. The said departments include the Department of Bioengineering & Technology, Biotechnology, Botany, Zoology and the University Hospital. The FRESH AIR, for its Biomedical Waste Management Program, offers their service to the OCCUPIER. By entering in to the agreement the OCCUPIER also has shown its concern to work against bio-hazard, which may be caused by medical and biomedical herein after called Biomedical Wastes and has agreed to join hands with the FRESH AIR under the following terms and conditions.

- 1. WASTE MANAGEMENT:** The solid wastes once generated will be segregated and stored in colour coded waste bags in an isolated place by the OCCUPIER from where it will go for different treatment procedure. The OCCUPIER will depute one person who will hand over the Biomedical Wastes to FRESH AIR as per the scheduled time only after proper segregation. The Details of the wastes to be collected to FRESH AIR have given in schedule 1. FRESH AIR will not collect any waste, which is not segregated.
- 2. COLLECTION, TRANSPORTATION AND DISPOSAL:** The FRESH AIR will be fully responsible for proper collection of Biomedical Waste from the end point of the OCCUPIER and their transportation, treatment & disposal of Biomedical Waste strictly in accordance with the instructions issued by Pollution Control Board (PCB), Assam, Guwahati from time to time.
- 3. WASTE DELIVERY:** The OCCUPIER undertakes to deliver to the FRESH AIR only the segregated Biomedical Waste generated by the OCCUPIER. Bags should be duly signed and tagged. General Waste i.e. (MUNICIPAL SOLID WASTE IS NOT TO BE PUT INTO THE COLOUR CODED BAGS AT ALL). The FRESH AIR shall not collect waste Bags containing un-segregated waste. Disposal of discarded linen, mattresses, beddings contaminated with blood or body fluid etc if required, separate arrangement for collection, disposal and payment will be made by both the parties with necessary planning.
