- 5.4 No Party shall, except without prior consent of the other Party, use, disclose, or reproduce any information contributed to or resulting from the projects/activities for any purpose other than the pursuit and the development of the project. The aforesaid confidentiality undertaking shall survive the termination of this MoU and shall remain valid and in full force and effect for 3 (three) years from the effective date of such termination.

- 6.1 The Intellectual Property (IP) arising out of collaborative projects/activities undertaken under this MoU shall be jointly held in the name of OIL and GU wherein OIL will be the first Party, mentioning inventors from both sides. OIL will be responsible to file, maintain and defend the IP against any claim and/or possible encroachment using its resources. However, technical support if required to defend any claim and/or possible infringement will be provided by GU.

This Memorandum of Understanding (MoU) is executed on the 11th day of August, 2022, between Gauhati University, Guwahati, Assam-781014, referred to as GU and Bodoland University, Debargaon, Kokrajhar, Assam-783370 hereinafter referred to as BU, through their authorized representatives, the Head of Department of Information Technology, GU and the Registrar, BU.

Wherein:

Gauhati University is with its long standing reputation and experience as the pioneering University in the North-Eastern (NE) region of India, engaged in Teaching-Learning, Research & Development, and Knowledge Sharing. GU recognizes its strengths in different fields and engages itself performing Research & Development activities in different domains that will create new opportunities for the society. A resourceful environment to promote creativity and innovation amongst people is also being created while maintaining sustainable goals to enrich the lives of humanity through enhancement of knowledge.

The Department of Information Technology, GU (GUIT) has been established to facilitate a state-of-the-art infrastructure for different academic and various Research & Development programs in the field of Computer and Information Technology. GUIT also encourage output-oriented research on region-specific problems and requirements, as well as contemporary and state-of-the-art universal problems, including interdisciplinary areas.

Bodoland University (BU), Kokrajhar was created way back in the year 2009 by an Act of Assam Government with a view to providing higher education to the people of Bodoland Territorial Region (BTR) for building a strong foundation of Knowledge, Skill and best practices to excel in life. Earlier this University was a campus of Gauhati University. Though the Bodoland University is relatively young, yet it is growing very fast to provide necessary education as per the need of the hour. It gives access to quality higher education to a wide region. The University is situated at Rangalikhata, Debargaon which is about 9 KMs away from the heartland of the BTR, i.e Kokrajahr town. The university has the potential to foster liberal exchange of knowledge and ideas beyond the territorial boundaries of the BTR.

As BU is in BTR where Bodo is the main official language, so BU is responsible for the development of Bodo Language, Bodo language teaching and research and making the language resourceful. Already research works in development of Language Technology, Speech Analysis, Speech Reorganization, Speech Synthesis, Natural Language Processing (NLP) etc. in Bodo Language have been initiated by the Department of Computer Science & Technology (CST) of BU. The CST department has been involving in Bodo Language development research works at the level of Masters and Ph.D. level Dissertation/Thesis.

Now:

GU and BU therefore agree to establish a framework for research and development works, co-operation in the areas of mutual interest and in accordance with terms and conditions set forth in this MoU. Both the parties have come forward to work together in the form of collaboration in Research & Development works in the field of Language Technology Development, specifically in Tools and Technology Development in local languages like Assamese and Bodo.

Both Parties have agreed to do and hereby execute this MoU in order to enable Research & Development, Innovation and Training etc. in associated sector and the aforesaid parties have agreed upon the terms, assurances, obligations and commitments as set out herein below:

1. Objective/Goal

The Goal is to foster research and development collaboration, facilitate advancement of Knowledge and Skill on the basis of reciprocity, best effort and mutual benefit.

2. GU and BU Agree

- a. To work on mutual interest, in the area of Language Technology Development, specifically related to the ongoing works of Local Language Technology-Application Development being carried out in the Department of IT, GU.
- b. To exchange knowledge and information on research and development works, particularly in the design, development of Local Language tools and applications development.
- c. To exchange resource and information on the engaged R&D activities and other facilities relevant to their mutual research and development works.

- d. To jointly organize required and necessary meetings, workshops, seminars, other programmes etc. in the topics and joint engagement.
- e. To joir..iy propose and engage in research and training programs as well as exchange of academic resources, research, and sharing of publications.
- f. To exchange technical and other human resources.

3. Description of Particular Activity to be engaged in:

It is agreed that both the parties will work for joint development of different Local Language Technology and Applications specifically, and in general Technology and Application development in the areas of AI and ML.

Specific Roles and Responsibilities of BU:

- BU shall specifically provide support to the ongoing Machine Translation Project, in terms of creating Large Parallel Corpus on Bodo-English and Bodo-Assamese.
- BU hall arrange necessary equipment, facilities and infrastructure, including managerial support in order to creating the large parallel corpus Bodo-English and Bodo-Assamese.
- iii. BU shall work on identifying necessary expertise, trained manpower for creating the parallel corpus, and also shall look at maintaining the quality of the parallel corpus, including validating the data set.
- iv. BU shall also contribute in developing/partnering in developing AI/Machine Intelligence-based tools for Machine Translation and NLP-oriented works applicable for the Web Application/Hybrid Mobile App in the field of Natural Language.
- v. BU shall provide relevant technical know-hows, and sharing of existing technical and trained manpower, whatever available.
- vi. BU shall provide requisite documentary support for preparation of R&D reports.

Mutual .greement:

- i. The scientific information and resultant outputs generated from the collaborative works will be shared by both GU and BU.
- ii. This MoU will come into force upon affixing the signatures of the

representatives of both GU and BU and will remain valid for three years from the date of signing the agreement. This may be executed for a further period if both GU and BU agree to the terms and conditions laid for such extension.

Both Parties have agreed to do and hereby execute this MoU in order to enable Research & Development, Innovation and Training etc. in associated sectors and the aforesaid parties have agreed upon the terms, assurances, obligations and commitments as set out herein below:

1. Objective/Goal

The Goal is to foster research and development collaboration, facilitate advancement of Knowledge and Skill on the basis of reciprocity, best effort and mutual benefit.

2. GU and KU Agree

- a) To work on mutual interest, in the area of Language Technology Development, specifically related to the ongoing works of Local Language Technology-Application Development being carried out in the Department of IT, GU.
- b) To exchange knowledge and information on research and development works, particularly in the design, development of Local Language tools and applications development.
- c) To exchange resource and information on the engaged R&D activities and other facilities relevant to their mutual research and development works.
- d) To jointly organize required and necessary meetings, workshops, seminars, other programmes etc. in the topics and joint engagement.
- e) To jointly propose and engage in research and training programs as well as exchange of academic resources, research, and sharing of publications.
- f) To exchange technical and other human resources.

3. Description of Project/Activity

It is agreed that both the parties will work for joint development of different Local Language Technology and Applications specifically, and in general Technology and Application Development in the areas of AI and ML.

Specific Roles and Responsibilities of KU:

- KU's expertise of design and development of Software, specifically Applications for Desktops, and Mobile platforms, shall be best used for the agreed collaboration.
- ii. KU shall arrange necessary equipment and establish necessary facilities for the development and management of AI/Machine Intelligence-based tools for Machine Translation and NLP-oriented work applicable for the Web Application/Hybrid Mobile App in the field of Local Language Technology/Tools/Applications development.
- iii. KU .nall provide relevant technical know-hows, and sharing of existing technical and training manpower and facilities, whatever available.
- iv. KU shall provide requisite documentary support for preparation of R&D reports.

Mutual Agreement:

- i. The scientific information and resultant outputs generated from the collaborative works will be shared by both GU and KU.
- ii. This MoU will come into force upon affixing the signatures of the representatives of both GU and KU and will remain valid for three years from the date of signing the agreement. This may be executed for a further period if both GU and KU agree to the terms and conditions laid for such extension, based on future requirements.
- iii. This agreement or its renewal and the action taken under it may be reviewed at any point in time. Modification may be made by mutual agreement and any remember to the agreement may be formulated by exchange of letters between the two parties.

4. Amendment

Save as expressly provided in this MoU, no amendment or variation of this MoU shall be effective unless in writing and signed by a duly authorized representative of each of the Parties.

5. Assignment

Neither party shall without prior written consent of the other party, assign, transfer, change or deal in any other manner with this MoU or its rights under it or part of it, or purport to do any of the same, nor sub-contract any or all or its obligations under this MoU.

6. Communication

All the notices, demands and other communication under this agreement in connection herewith shall be written in English Language and shall be sent to the last known address, email, or fax of the concerned party. Any notice shall be effective from the date on which it reaches the other party.

7. Resolution of Disputes

- a. This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction to the courts at Guwahati.
- b. The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between themselves, failing which the matter shall be referred to and settled through mediation committee; if mediation failed then through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be Guwahati and Language of arbitration shall be English.
- c. This MoU indicates the intention in brief about the proposed collaboration by GU, and the possible facilitation to be extended by KU, and shall remain valid only for a maximum period of 36 months from the date of entering into MoU unless otherwise extended mutually by both the parties.



This Memorandum of Understanding (MoU) is executed on this day of 27 June, 2023 between the Department of Library & Information Science, Gauhati University, Guwahati, Assam-781014, India - The First Party; herein referenced as "DLIS, GU"

And

Department of Library & Information Science, Cotton University, Guwahati, Assam-781001, India as the Second party; herein together referenced as "DLIS, CU"

Gauhati University is the oldest and largest university in the North-Eastern part of the county established in the year 1948 and has celebrated its Platinum Jubilee in the year 2023. Being the oldest and the largest university in the entire Northeast, the university represents the academic and cultural background of the region, on which the other academic institutions of Northeast India started their journey. Being the pioneer educational institute, it extends its hand holding support to all subsequent academic institutions in this region. Gauhati University is an affiliating University. The university has a huge academic structure with 49 Postgraduate Academic Departments, 2 constituent institutes, 1 constituent college and 300+ affiliated colleges. The Department of Library and Information Science, Gauhati University is the first post graduate and premier department of library and information science in the entire North-East India established in 1966 with Bachelor of Library Science (B.Lib.Sc.) programme. In the year 1979, one-year Master of Library Science (M.Lib.Sc.) programme was introduced. Both the B.Lib.Sc. and M.Lib.Sc. programmes become one-year full time day programme in the year 1983, and in the year 1985, the programmes were re-structured into Bachelor of Library and Information Science (B.L.I.Sc.) and Master of Library and Information Science (M.L.I.Sc.), respectively with major changes in the syllabus as per the UGC guideline. The department started Ph.D. programme in 1987. Again, as per UGC guidelines two years integrated M.L.I.Sc. programme with four semesters has been introduced in the academic session 2001-02 in place of the earlier one-year B.L.I.Sc and M.L.I.Sc prgramme. The department launched M.Phil. programme in the year 2016 but discontinued in the year 2021 as per UGC regulation 2018. Along with the University, the syllabus of the M.L.I.Sc. programme has been switched over to Learning Outcome based Curriculum Framework (LOCF) accommodating all probable dimensions of developments in the subject as well as the demands witnessed in the skills of learners towards reaching out to the expectations of the diverse work environments, both government and corporate sectors.

Cotton College is known as a leading educational hub for its rich heritage and legacy of nurturing new generations to get themselves equip with the challenges of time and thereby lead the country towards prosperity. Cotton University has been established with the commitment of the Cotton College to carry forward the rich legacy. Department of Library & Information Science, Cotton University, established in the year 2019 as a new department in Cotton University. The Department of Library & Information Science, Cotton University started two-year integrated Post Graduate programme Master of Library & Information Science (M.L.I.Sc.) in the year 2020. The department has started PhD programme in the year 2023. The syllabus of the department has been aligned to the state-of-the art national and global standards in the field of library & information science. The department has put significant thrust to train the learners and get themselves adapted with the necessary skill in the frontier areas of information management and innovation. To this end, efforts put by the department are not confined to the classroom teaching-learning environment, but also trying to provide exposures to interact and learn from the subject experts at different institutions in the country as well as abroad through whatever possible channels.

Whereas the DLIS Cotton University desires mentorship of the DLIS, Gauhati University in some academic programmes as and when necessary, in order to achieve its objectives, the following areas are identified and agreed upon mutually, but not necessarily limited to

- 1. **Mentorship** DLIS Gauhati University will extend academic support to DLIS Cotton University as a mentor department as and when sought for by the later.
- 2. Collaborative Research Projects Faculty members of DLIS, GU and DLIS, CUmay undertake joint research projects and submit proposals for possible funding to different funding agencies.
- 3. **Joint organization of Seminar/ Symposia/ Workshop** —Seminar/Symposia/Workshop may be organized jointly by the DLIS, GU and DLIS, CU.
- 4. **Training and Internship of Students** Both the University departments will give due priority to the students of each other University in pursuance of summer and/ or winter internship programmes as and when organized, and extend necessary help and guidance to undergo similar programmes in the University libraries of both the universities.
- 5. Training and Career Counseling Both the University departments may jointly organize special training programme for different competitive examinations, and programme of career counseling at convenient time on mutual consultation.
- 6. **Placement of Students** Both the University departments may help each other to provide placement opportunities to the students based on eligibility and industry requirements.
- 7. **Financial Obligation**—This is a non-binding MoU and there shall be no financial obligations on any of the parties with regard to execution and realization of the above stated areas of collaboration.

Both DLIS, GU and DLIS, CU agree that any information which is exchanged pursuant to this MoU will be kept strictly confidential and used solely for the purpose covered by this MoU, unless such information, that was obtained by a third party who do not have obligation of confidentiality towards the information-disclosing party and has entered public domain.

The following principles will be abided by regarding termination of this MoU.

o This MoU shall enter into effect from the date of signing and shall be valid for a period of three years.

o Nothing mentioned in this MoU shall be deemed to constitute partnership between the signing universities or university departments appointing one party as the agent of the other.

This MoU will be effective upon signature by both the Registrars of Gauhati University and Cotton University. The Head of the Departments of DLIS Gauhati University and DLIS Cotton University will act as nodal officers for execution of the academic activities in the MoU.
