

Sub: Uniform Policy of Admission of Students into the Colleges in different Streams of Government and Provincialized Colleges of Assam.

The State Government has been actively considering the need for making Uniform Policy of admission of the students into the Degree Colleges in different streams of Government and Provincialized Colleges of Assam.

Accordingly, following instructions / guidelines are Issued for compliance by every college authority with immediate effect, i.e., from the current year 2014-15.

- Henceforth, the college authority should declare the numbers of seat to be offered for admission in each stream at the beginning of the Session.
- ii) Admission Notice is to be published in the local Daily Newspapers, both English and Assamese, or in Notice Board of the colleges indicating the category-wise total number of seats to be offered for admission.
- The admission should be on the basis of merit list prepared based on the marks obtained in the qualifying examination subject to Government Reservation Policy.



- given below for outstanding Sports Persons / NCC Cadets / proficiency in cultural activities / wards of the employees of the colleges, etc.
 - (a) 2% for Sports Persons of sports recognized by IONSAI and
 - (b) also have represented District/ State, etc.
 - (b) 1% for wards of employees of the college and
 - (c) 1% for NCC/Scouts/ Guides.
 - (ci) 1% for the students with achievements in cultural activities. These seats are to be settled on the basis of merit list of students concerned in each category. The detailed guidelines for filling up of these seats may be finalized by the Governing Bodies of the Colleges.
- v) There shall be no discretionary Quota of Seats to be filled up by the Principal or any other authority.
- vi) No seats will be offered for admission by the College Authorities against donations to the college fund.
- vii) The Principal of the College will notify the closure of admission in any academic year and publish category-wise the names of students with marks etc. who are admitted to the college in the Notice Board / College Website. A copy of the same will also be submitted to the Director, Higher Education for information.

The above instructions should be followed scrupulously by all concerned starting with the admission for the academic year 2014-15. Any deviation from the above will be viewed seriously and will invite disciplinary actions.

Quota of OBCs in higher education

The University Grants Commission(UGC) has circulated the Central Educational Institutions (Reservation in Admission) Act, 2006 and Amendment Act, 2012 to all Central Educational Institutions directing them to implement reservation provisions for Other Backward Classes (OBCs) including admission of OBC students to these Institutions. UGC has issued instruction to all the grant-in-aid institutions funded by the Central Government, except minority Institutions under Article 30(1) of the Constitution of India to implement 27% reservation for OBCs.

As per the information available with the Ministry, during 2015-16, 22 out of 40 Central Universities have successfully achieved the prescribed percentage of student intake from OBC Community. Some of the universities like Aligarh Muslim University, Jamia Milia University and some like Mizoram University, Nagaland University, North Eastern Hill University could not achieve the prescribed percentage as these were either minority institutions or were situated in Tribal dominated areas where less OBC students apply for admissions. All Indian Institutes of Technology/National Institutes of Technology/Indian Institutes of Information Technology achieved the stipulated 27 % intake of OBC students. Further, 13 Indian Institutes of Management out of 19 and 22 out of 31 National Institutes of Technology recorded more than the stipulated 27% student intake.

The Government of India and UGC has been continuously monitoring the progress of implementation of Reservation policy for OBCs in admission to courses at all level in Universities/Institutions.

The Ministry of Human Resource Development through UGC instructs Universities/Institutions to furnish periodic reports on the implementation of reservation guidelines for OBCs for admissions to courses at all level and Hostel accommodation for students.

UGC has a dedicated SC/ST/OBC section which monitors effective implementation of the Reservation Policy for all communities including OBCs in admission and recruitment to various posts in universities and colleges.

This information was given by the Minister of State (HRD), Dr. Mahendra Nath Pandey today in a written reply to a Rajya Sabha question.

National Policy for Persons with Disabilities

Introduction

The Constitution of India ensures equality, freedom, justice and dignity of all individuals and implicitly mandates an inclusive society for all including persons with disabilities. In the recent years, there have been vast and positive changes in the perception of the society towards persons with disabilities. It has been realized that a majority of persons with disabilities can lead a better quality of life if they have equal opportunities and effective access to rehabilitation measures.

2. According to the Census 2001, there are 2.19 crore persons with disabilities in India who constitute 2.13 percent of the total population. This includes persons with visual, hearing, speech, locomotor and mental disabilities. Seventy five per cent of persons with disabilities live in rural areas, 49 per cent of disabled population is literate and only 34 per cent are employed. The earlier emphasis on medical rehabilitation has now been replaced by an emphasis on social rehabilitation. There has been an increasing recognition of abilities of persons with disabilities and emphasis on mainstreaming them in the society based on their capabilities. The Government of India has enacted three legislations for persons with disabilities viz.




- 27. Persons with disabilities will be provided access to the Universities, technical institutions and other institutions of higher learning to pursue higher and professional courses.
- II C Economic Rehabilitation of Persons with Disabilities
- 28. Economic rehabilitation of Persons with disabilities comprise of both wage employment in organized sector and self-employment. Supporting structure of services by way of vocational rehabilitation centres and vocational training centres will be developed to ensure that disabled persons in both urban and rural areas have increased opportunities for productive and gainful employment. Strategies for economic empowerment of persons with disabilities would be the following.

(i) Employment in Government Establishments

The PWD Act, 1995 provides for 3% reservation in employment in the establishments of Government of India and Public Sector Undertakings (PSUs) against identified posts. The status of reservation for Government in various Ministries/ Departments against identified posts in Group A, B, C & D is 3.07%, 4.41%, 3.76% and 3.18% respectively. In PSUs, the reservation status in Group A, B, C & D is 2.78%, 8.54%, 5.04% and 6.75%, respectively. Government will ensure reservation in identified posts in the Government sector including public sector undertakings in accordance with the provisions of the PWD Act, 1995. The list of identified posts, which was notified in 2001, will be reviewed and updated.
