

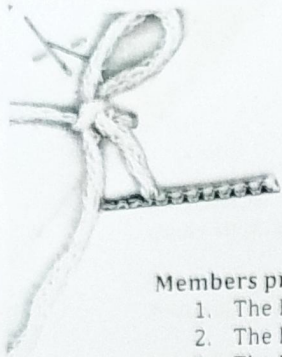
Change of name of course


(i) Regarding Faculty Positions in Departments.

The Dean as Chairperson of the meeting welcomed all the members and took up the agenda for discussion. He informed the members present that the Head, Department of Library and Information Science and Head, Department of Linguistics and Head, Department of Foreign Languages have sent their representatives to attend the meeting while the Heads of the Departments of Psychology, MIL and Literary Studies, Women's Studies and Journalism and Mass Communication had informed of their inconvenience to attend the meeting.

Agenda 1 : To finalize necessary instructions, procedures and modules of online Practicals to be conducted for the Undergraduate and Post Graduate Examinations in the GU PG departments/colleges/ institutes affiliated to Gauhati University.

The Chairperson placed the matter for discussion before the Council. He informed the members that as per records available, the Departments having Practical components in their UG or PG Programme are – Education (both UG and PG), Library and Information Science (PG), English Language Teaching (PG) and Psychology (both UG and PG).

Prof. Polee Saikia, Head, Department of Education informed the members that the Practical components of Education in the UG programme are in the fifth semester and there are no Practicals in the sixth semester; while in the PG programme, the Practicals are in the Third

Semester and there are no Practicals in the Fourth Semester. She informed that the procedure for conducting the Practicals in the Third Semester of the PG course and Fifth Semester of the UG course has already been accepted and implemented by the Controller of Examinations. According to the revised PG CBCS syllabus in Education (2020), the Practical course is in Second semester which is currently being conducted in the Online mode.

Prof. Padmini Boruah, Head, Department of English Language Teaching informed that the Practicals of their PG programme would be conducted in the online mode due to pandemic related restrictions in coordination with Assam Jatiya Bidyalay, Guwahati and that the department has already finalised the modalities for the same.

The members also discussed the necessity of proper recording of the guidelines and processes. In the light of this the respective Heads of the Department of Education and the Department of ELT were requested to share their guidelines for Practical exams with the Faculty for the official record as well as for future reference.

Dr. Tilak Hazarika representing the Head, Department of Library and Information Science informed the Faculty that the PG programme in their department has a practical component in every semester and that while some of the components have been taught in the Online mode, it has not been possible to conduct the Practicals. The software package that is an essential part of practical learning cannot be set up remotely, and the physical presence of students is absolutely imperative for learning.


The members further discussed the matter in the light of the problems faced by the departments and the steps taken to overcome the same. The members also unanimously opined that considering the core nature of the Practicals of the Library and Information Science Programme, the students of that department may be allowed to attend supplementary Practical Sessions like Workshop/Training programme/Summer School as decided by the Department to fulfil the outcome requirement of the Programme. The Chairperson expressed that such a measure might benefit other departments as well.

Accordingly, the following two resolutions were adopted:

Resolution No 1 : Resolved that the Dean, Faculty of Arts be authorised to approve and forward the necessary instructions, procedures and modules of online Practicals to be conducted for the Undergraduate and Post Graduate Examinations as recommended by the concerned Departments to the Controller of Examinations, GU.

Resolution No 2 : Considering the core nature of some of the Practicals without which the graduates of the PG programme of the Library and Information Science Programme would be deprived of basic knowhow of the subject and as completing the necessary Practicals is not feasible in the Online mode, be it resolved to recommend that the students of that department be allowed to attend supplementary Practical sessions through Workshop/Training programme/Summer School as decided by the Department to fulfil the outcome requirement of the Programme. Resolved further that the same be recommended for other departments conducting PG programmes under similar circumstances.

Agenda No. 2: To recommend a last date for completion of Second Semester PG Courses



The members discussed the matter in the light of the fact that the departments under the Faculty of Arts are at different stages of progress. After a detailed discussion the members came to a consensus and decided to fix 31.08.2021 as the last date on or before which the Second Semester PG Courses need be completed.

Accordingly, the following resolution was adopted:

Resolution No 3: Resolved that the last date for completion of the Second Semester PG Courses be fixed as 31.08.2021.

The members also discussed the matter of examinations of the Second semester classes in view of the UGC guidelines reportedly recommending only terminal semester examinations. The members unanimously opined that the examination for the Second Semester be held in the Open Book mode.

There was also discussion on the various problems faced by faculty members in conducting Online classes. The members unanimously expressed the need of a dedicated Learning Management System for Gauhati University and recommended that the matter be pursued with the GU authorities.

Agenda No. 3. Modification of CBCS Regulations.

The Chairperson informed the members that the Choice Based Credit System (CBCS) Regulations of Post Graduate Programmes of Gauhati University (GU) were adopted in 2016 as ratified by the Academic Council on 31.05.2016. He reminded the members of the urgent need to revisit the Regulations as five years have passed since their introduction and no academic audit took place during this period. The members discussed the matter and expressed the opinion that the credit requirement for PG programmes appears to be on the higher side. The members took into cognizance Clauses 3 (iii) and 5 (a) which stipulate that for every 6 (six) credit course there needs to be a minimum of 90 classes per course. The members discussed and unanimously agreed that it is almost impossible to have a minimum of 90 classes for a six credit Course under a normal academic calendar. The members after a detailed discussion decided to resolve as follows:

Resolution No 4 : Resolved that the Vice Chancellor, GU be requested to Constitute a Committee to examine the existing Regulations of the Choice Based Credit System (CBCS) Post Graduate Programmes of Gauhati University (GU) and recommend modifications especially on the provisions relating to credit limits.

Agenda No 4: Modification of PG syllabuses in conformity with Outcome Based Education Model (OBE).

The Chairperson placed the matter and informed the members that most of the syllabuses of the PG Programmes in the university were approved in 2016 and have been in force since then. The members discussed the matter and opined that the true philosophy of Outcome Based Education is yet to be fully realised in GU though the syllabuses have all incorporated Programme Outcome (PO) and Course Outcome (CO). The members discussed the matter in details and opined that as OBE is also being emphasized upon by the National Education Policy 2020, so it has become necessary to incorporate the OBE principles in the syllabuses. The

members discussed the matter in detail and considering the fact that the next academic session would start from 01.10.2021, decided for revision of all syllabuses in the PG departments under the Faculty of Arts.

The Head, Department of Hindi informed the members that the new syllabus in Hindi had already been submitted to the Office of the Academic Registrar. The Chairperson informed the Department that as the syllabus could not be placed in the meeting, the same may be considered in the next meeting of the Faculty Council.

Resolution no 5 : *Resolved that the syllabuses of the PG Programme in all the departments under the Faculty of Arts be revised so that the same may be implemented with effect from the new academic session w.e.f. 01.10.2021*

Agenda No 5 : Any other matter : In any other matter, two items were placed for discussion.

- (i) **Regarding Self-Financed Programmes :** The members discussed the matter of existing Self-financed Programmes at GU. The Head, Department of Education informed that the M.Ed. programme, which is highly in demand is being conducted in the self-financed mode. However, on inquiry by members about the Ordinance or Regulations under which the said Programme is being conducted, it was revealed that the guidelines are there in file notes, but not in the form of an Ordinance or a consolidated GU Regulations. The members discussed the matter threadbare and opined that in the days to come, departments may be required to introduce relevant self-financed modular Programmes for which a proper Ordinance may be helpful and necessary. The members finally decided to resolve as below:

Resolution No 6: *Resolved that the Vice Chancellor, GU, be requested to constitute a Committee to draft an Ordinance for the Self - Financed Programmes of Gauhati University.*

- (ii) **Regarding organising Faculty Colloquium :** A few members forwarded a view that there is a need for a platform where faculty members who have returned from academic exchange programmes abroad may be able to present their ideas and experiences. The members discussed and opined that the Dean, Faculty of Arts may explore the possibilities of facilitating/ organizing colloquiums where faculty members would be able to present their experiences of their engagement with foreign universities.

As there was no other matter left for discussion, the meeting ended with a vote of thanks from and to the Chair.
